1. Call to Order

- B. There was discussion regarding the creation of a brochure/pamphlet for the Senior Center.

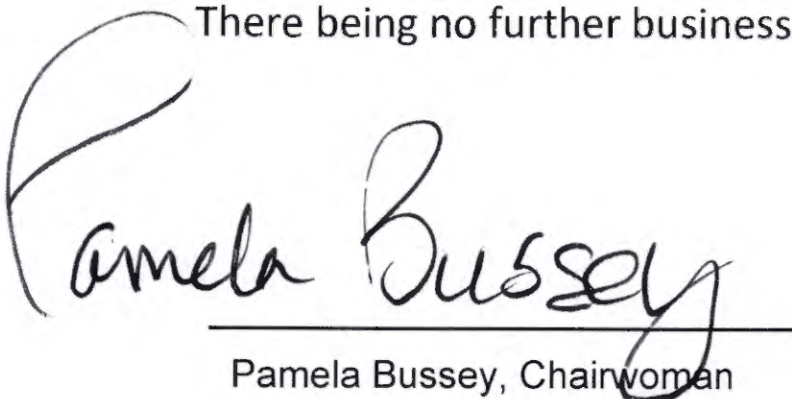

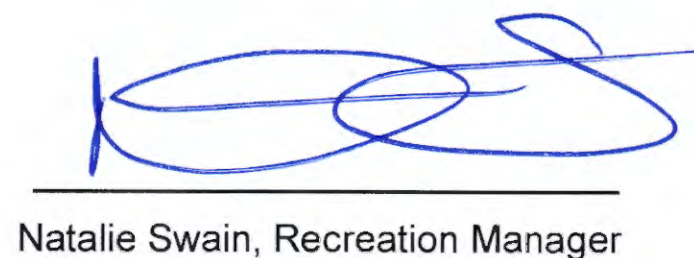
