1. Call to Order

Meeting called to order at 3:08pm.

2. Roll Call/Determination of a Quorum (Minimum 4 Present Required)

3. Approval of Minutes of 6/10/24 and 8/12/24 Meeting

Marjorie motioned to approve the 6/10/24 minutes as edited, Stephen seconded. There were no edits for the August meeting. Minaz motioned to approve the 8/12/24 minutes, Marjorie seconded. The motions passed unanimously.

The League of Women Voters will be doing a seminar on ballot amendments on September 18th at 12pm.

The motion was passed unanimously, but there was discussion about needing a representative from PD/FD to get involved.**

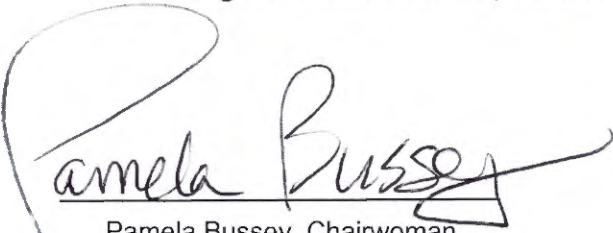
